The Journal of Agricultural Faculty of Uludağ University is biannually published and the journal welcomes original research articles, review articles and letters to editor on all aspects of agriculture, plant protection, horticulture, animal science, fisheries and aquaculture, dairy technology, food science and technology, and biological sciences. Submitted manuscript must be original and written in English or Turkish language. Submitted study has not been published before. However, only abstract of the submitted manuscript may be previously presented or published in a congress or symposium. Manuscript must be typewritten in **12-point font Times New Roman** on one side of the page only, double-spaced with 3 cm margins to all sides, limited to a maximum 20 pages. Moreover, line numbers must be used for each page, individually. Table(s) and figure(s) with legend(s) should be separated from text and take places at the end of the text (**Sample Manuscript**). The file type/format of the manuscript must be in the Microsoft Word format (*.doc type). Manuscript must be send by e-mail to editor. (zfdergisi@uludag.edu.tr)

A submitted manuscript must contain the main subjects, which described below.

- ❖ Title
- ❖ Name(s) of the author(s)
- ❖ Abstract and key words
- ❖ Introduction
- ❖ Material and Methods
- ❖ Results and Discussion
- ❖ Acknowledgement(s) (If necessary)
- ❖ References

Title: The title should be written with double space-bold and centered and first letter of each word should be capital. Footnotes (indication of MSc or PhD Thesis) to title should be indicated by superscript lower-case letters (or asterisks for significance values and other statistical data).

Name(s) of the author(s): Name(s) without a title is clearly indicated. Address(es) of the author(s) should be indicated with a superscript(s) number(s) under the name(s) as centered.

Abstract: Abstract should be brief but give clear information about the research and results obtained. This should not exceed 200 words. Below the abstract (one line space) provide maximum 7 key words.

Introduction: It provides importance of the research and contains basic studied that previously done.

Material and Methods: It should be clearly written and explained used method(s) in the study.

Results and Discussion: Obtained results from the study should be indicated in this section and they are provided by table(s) and/or figure(s), if necessary. Also, the results should be compared with similar studies that formerly done. Moreover, importance of the results should be expressed. However, it should be avoided unnecessary repetitions.

Table(s) and Figure(s): Legend(s) of table(s) and figure(s) should place above table(s) and below figure(s), respectively.

Ethical commission report: Authors should indicate the name of institute approves the necessary ethical commission report and the serial number of the approval in the material and methods section. If necessary, editorial board may also request the official document of the ethical commission report.

Citations/References: Citations in the text should be indicated using “author, year” format; Smith (2007), moreover, (Smith, 2007) if it is placed at the end of the sentence. For two authors, they are indicated as Smith and Cash (2007). Where three or more authors exist for a cited reference, the citation should be formatted as “first author et al. year”; Smith et al. (2007).

References should be listed in alphabetical order according to the last name of the first author. Use “and” in listing two or more than two authors. Example: Şeker, M., Z. Yücel and E. Nurdan, 2004.
