PLACEMENT AND ONLINE PRE-REGISTRATION PROCEDURES
FOR FOREIGN STUDENT ADMISSION QUOTAS

Registration Dates: July 10 – July 22, 2026 (It will end at 17.00 Türkiye Time)

Registration will be done online. Any candidates failing to register online within the specified period will lose their right to register. Candidates are required to carefully read and examine the documents required for registration. Registration will not be made with missing documents.

For the quotas that remain vacant after the first placement, second placement will be done and the results will be announced on Monday, July 27, 2026. For the **second placement**, new preference applications will not be received from the candidates; the second placement will be made from the existing candidate pool.

Candidates must login with the exact Passport / ID Card number provided during the application. **Candidates will not receive a Letter of Acceptance via e-mail.**

***** ONLINE PRE-REGISTRATION *****

Candidates who have the right to register will be sent an e-mail until July 10, 2026, to upload the following documents to the system. (E-mail addresses will be used in correspondence with candidates, so make sure that your e-mail address is used, updated, and correct. Information made to candidates' e-mail addresses is subject to official notification.) (Please check the e-mail address you entered in the system during the application for preference. Check that your mail is available for use and that you can receive mail.)

New documents are required besides those that have been uploaded to the system during online preference registration by the candidates who are eligible for registration;

a-) Bank Receipt showing that the fall semester tuition fee has been paid to the relevant bank after application number is obtained during registration, It will be deposited from Halk Bank branches, by indicating the Candidate Number to Bursa Uludağ University Fee Account, and entering the candidate number, name and surname in the explanation section or online application system by credit card. [(Fees will be paid from Halkbank Branches or by using credit card. EFT/TRANSFER will not be made, no fee will be charged to any other account of the University or IBAN number.) Applicants will pay the 1st semester payment (of their tuition fee during the registration. Registration cannot be completed if the payment is not rendered.)]

-Students who will be granted leave of absence to learn Turkish must pay the tuition fee of their faculty/vocational school as well.

[For the 1st semester (Fall Semester) contribution fees/tuition fees for the 2026-2027 academic year, any positive or negative difference in the contribution fees/tuition fees determined by the Board of Directors of our University among the contribution fees/tuition fees for the 2026-2027 academic year, (Considering that in previous years it was published starting from the second week of July) which will be in effect upon publication in the Official Gazette according to the Presidential Decision "Decision on Determining the Contribution Fees and Tuition Fees to be Taken as Student Contributions for Current Service Costs in Higher Education Institutions for the 2026-2027 Academic Year", will be collected along with the following Spring semester contribution fees/tuition fees. (Any positive or negative differences due to changes made by the competent authorities in the Decision to be announced, or due to the contribution fees/tuition fees determined by the Board of Directors, will be collected along with the following Spring semester contribution fees/tuition fees.) The amounts of Contribution Fees/Tuition Fees are announced to candidates on the ULUYÖS website.]

c-) Letter of Commitment Candidates are required to sign and upload the **Letter of Commitment** (**[Click here](#)** for the **Letter of Commitment**)

Candidates are required to upload the file to the upload button in the e-mail attachment sent to their e-mail address.

IMPORTANT: Prepare the required documents for online registration. [All documents to be uploaded must be in JPEG format (.jpg) and smaller than 2 MB.] You must upload the documents correctly to the links sent to you by e-mail. The links in the e-mail sent to you are for single use hence it is important not to upload a trial or different document. After the document is uploaded, the links cannot be used again.

ATTENTION: Candidates who register online are required to submit the original documents required for online registration and the originals of the documents below, which they have uploaded to the system during the preference application, to the student affairs of their units **until September 25, 2026**. Individuals who do not have a legal right of residence in Türkiye cannot be enrolled in university. The status of whether candidates have a legal right of residence in Türkiye (visa/residence permit) is evaluated within the scope of legislation determined by relevant Ministries and the Presidency of Migration Management. If it is determined that candidates do not have a legal right of residence in Türkiye, their registrations will be cancelled, and no refunds will be provided to these candidates.

REQUIRED DOCUMENTS FROM CANDIDATES ENTITLED TO DEFINITIVE REGISTRATION FOR FOREIGN STUDENT ADMISSION QUOTAS

1) A photocopy of the high school diploma or temporary graduation certificate

- (The original will be seen and copied. If in a language other than Turkish or English, a photocopy of the Turkish translation certified by a notary public or Turkish foreign representative offices is required.)

2) An official note card certified by the high school administration showing the courses taken, grades, and overall grade point average of the candidate in high school (The original will be seen and copied.) (Transcript)

- For diplomas and grade averages obtained from the Ministry of National Education of the Republic of Türkiye, excluding those written on the high school diploma,
- If in a language other than Turkish or English, a photocopy of the Turkish translation certified by a notary public or Turkish foreign representative offices is required.

3) Original Diploma Equivalency Certificate and a Photocopy Of High School Diploma, (The original will be seen and copied.)

- Photocopy of the high school diploma and the Equivalency Certificate obtained from the Provincial Directorate of National Education or Turkish Foreign Representations [If the Equivalency Certificate cannot be submitted until the start of the academic year, the relevant faculty/vocational school may grant an extension until the beginning of the 2027-2028 academic year. (Candidates are required to submit diplomas with "**Apostille**" approval for equivalence procedures by the Ministry of National Education. Candidates without an Equivalency Certificate must bring their diplomas approved with Apostille certification when coming from abroad. For Equivalency Procedures, [Click Here.](#))]

4) Copy of passport pages showing both entries to the country and exit from the country covering the high school education periods (for those who are Turkish citizens or have Blue Card and have completed their high school education abroad), or **Import / Export from the country Document** obtained via the E-government system (for those under the age of 18) [Considering that dual citizens with one nationality being Turkish, as well as those with Turkish nationality, having Blue Card and who are Foreign Nationals who have completed their entire high school education in foreign schools (excluding schools in the T.R.N.C.), can apply for admission quotas from abroad; applications for transition to higher education within the framework of foreign student admission quotas with diplomas obtained through distance education **from a foreign high school without being physically present abroad are not accepted**. For those who have obtained a diploma through formal education from a foreign high school, entries to the country and exit from the country where the diploma was obtained will be checked through passport or security records. If the duration of stay in the relevant country does not support that the high school education was obtained through formal education, applications with these diplomas within the framework of foreign student admission quotas will not be considered, and if it's detected, even if their registration was done their registrations will be cancelled at any stage. If they graduate, their diploma will be revoked.

5) Exam Result Document (For applicants whose exam result document does not have a verification code or whose exam results cannot be accessed from the system, the exam result documents must be sealed/signed or notarized.)

6) Copy of Passport/ID (For those who have a Turkish ID Card, copy of Turkish ID Card; for those who have a Residence Permit Card, copy of Residence Permit Card; for those who have a Blue Card, copy of Blue Card; for foreigners without these documents, copy of the first page, entry page, and visa page of the passport) (Original Document will be seen and copied.)

7) Copy of Residence Permit Card. ([Click Here for](#) the Residence Permit Application Procedures.)

(For those without a residence permit, they must submit the foreign identity number on the residence permit card they will obtain later to the relevant student affairs unit by the beginning of the academic year.)

8) "Certificate of Identity Register Copy" showing information about the foreign citizenship before acquiring Turkish citizenship, for those whose nationality includes Turkish citizenship (via e-Government Gateway).

9) Bank Receipt, indicating that the semester tuition fee/education fee has been deposited into the relevant bank. (For candidates who have earned the right to register, payments should be made to the Bursa Uludağ University Account at Halk Bank branches indicating candidate number, name and surname in the explanation section instead of the student number, as specified in the acceptance letter. For graduates from high schools designated by the Presidency for Turks Abroad and Related Communities (YTB) whose tuition fees will be covered by the YTB, no receipt is required. (These candidates will upload their high school diplomas instead of a receipt during online pre-registration.)

-For students exempted for learning Turkish through relevant programs, they will be responsible for paying the tuition fees for the programs at the faculties/vocational schools. [Click here](#) for the tuition fee amounts.

13) Photocopy of the Turkish Language Proficiency Certificate, (Those who do not bring any document regarding their Turkish language proficiency during the definitive registration will be considered to have A1 level of Turkish proficiency and their procedures will be carried out accordingly.)

-Turkish Language Proficiency Certificate is not required from students who have completed their entire high school education at a Turkish high school abroad (affiliated with the Turkish Ministry of National Education) or at a high school in Türkiye. [The duration of the Preparatory Class (Turkish or Foreign Language) is 2 years, and the registrations of candidates who fail to complete this period will be deleted.]

14-) General Health Insurance ([GSS](#)) Certificate (International students who have entered or will enter Türkiye will be required to obtain General Health Insurance ([GSS](#)) from the Social Security Institution Presidency.) or Private Health Insurance Certificate. 16) Foreign nationals who have completed their entire high school education at the embassy schools or international private educational institutions listed in MOBIS system must obtain a certified official document from their schools/official institutions confirming that they have completed or will graduate from those schools.

17) Health Report and Criminal Record (Airline Transportation Management Department) from candidates admitted to the Civil Aviation Management Department ("See, Quota table Special Terms and Conditions")
