2- APPLICATION CONDITIONS

A) On the condition that they are senior students at high schools or graduates, the applications of the applicants who;

1) Hold foreign nationality, (provided that they have not studied in or graduated from upper secondary (high school) institutions in Türkiye (excluding those studying at embassy schools, international private educational institutions listed in the MOBİS system, and foreign nationals who have come to Türkiye within the scope of projects carried out by the Ministry of National Education and the Council of Higher Education);

2) Were Turkish citizens by birth but later lost Turkish citizenship by obtaining permission to renounce it from the Ministry of Interior, or certify that they hold a Blue Card issued upon request to persons who have lost Turkish citizenship (provided that they have not studied in or graduated from upper secondary (high school) institutions in Türkiye (candidates applying under international student admission quotas are advised to review Article 7 of the Turkish Citizenship Law No. 5901);

3) Acquired Turkish citizenship subsequently while originally being foreign nationals or hold dual nationality in this status (provided that they have not studied in or graduated from upper secondary (high school) institutions in Türkiye);

4) Turkish citizens who have completed their entire high school education in a foreign country excluding TRNC high schools (including Turkish high schools established by the Ministry of National Education of Türkiye in a foreign country.)

5) Those who have a TRNC citizenship, reside in the TRNC, have completed their secondary education in the TRNC and hold GCE AL exam scores, and those registered and educated in high schools in other countries between 2005 and 2010 and hold, or will hold, GCE AL exam scores; or, have a TRNC citizenship, having completed their entirety of their high school education and having attained a TR-YÖS score.

will be accepted.

B) The following candidates cannot apply as per the scope of international student admission quotas:

1) Turkish citizens who have completed their entire of secondary education (high school) in Türkiye or the TRNC,

2) Citizens of the TRNC (excluding those who have completed their entire secondary education in TRNC high schools and hold GCE AL exam scores, and those registered and trained in high schools in other countries between 2005-2010 and hold, or will hold, GCE AL exam scores; or, have a TRNC citizenship, having completed their entirety of their high school education and having attained a TR-YÖS score)

3) Dual citizens who hold a TR citizenship by birth as defined in paragraph (a) item (2) above (excluding those who meet the provisions under paragraph (a) item (4) of the same article),

4) Dual citizens who hold a TRNC citizenship (excluding those who have completed their entire secondary education in TRNC high schools and hold GCE AL exam scores, and those registered and trained in high schools in other countries between 2005-2010 and hold, or will hold, GCE AL exam scores; or, have a TRNC citizenship, having completed their entirety of their high school education and having attained a TR-YÖS score)

5) TR citizens who have received education in high schools in any embassy or foreign high schools in Türkiye, or dual citizens whose nationality by birth is TR within the scope of paragraph (a) item (2),

6) a) TRNC citizens and those who have renounced Turkish citizenship/blue card holders and those receiving secondary education (high school) or having graduated from any secondary educational institution in Türkiye or TRNC.

b) Foreign nationals receiving their secondary education (high school) or having graduated from any secondary educational institution in Türkiye (excluding foreign nationals who are students in embassy schools and international private education institutions listed in the MOBİS system, and those who come to Türkiye within the framework of the project implemented by the Ministry of National Education).

ATTENTION;

1-Since it is essential to be educated in the relevant country during high school education, those who have graduated from the Open Education High School abroad program affiliated with the Ministry of National Education by documenting that they have been in the relevant country for the years corresponding to the high school education will also be able to apply for student admission quotas from abroad.

2-The decision taken at the General Assembly meeting of the Council of Higher Education (YÖK) on November 21, 2024, regarding the continuation of the practice of accepting applications from candidates from Balkan countries who have completed/graduated from high schools in Türkiye to the international student admission quotas of various universities, refers to candidates from Balkan countries who have completed/graduated from high schools in Türkiye.

In addition to those who are citizens of Balkan countries, those residing in Türkiye;

-Dual nationals who hold Turkish citizenship and also citizenship of one of the Balkan countries,

-Those who lose their Turkish citizenship by obtaining permission from the Ministry of Interior to renounce their Turkish citizenship,

-Applications for international student quotas from individuals who have lost their Turkish citizenship and can document that they hold a blue card (issued upon request) have been deemed ineligible.

Bursa Uludağ University reserves the right to make changes to this guide and the announced conditions in accordance with the decisions and/or legislative provisions of the Council of Higher Education (YÖK), the University, and relevant authorities that will come into effect after the publication date of this guide. All applicants and registered candidates are deemed to have accepted these regulations

Any candidate applying to Bursa Uludağ University is deemed to agree to all of the conditions specified in this manual and the [Instruction Of Bursa Uludağ University Student For Abroad Or Foreign Student Application And Admission Procedure](#). [Click here](#) for the Directive.

3- GUIDELINES, FUNDAMENTAL PRINCIPLES AND RULES

3.1. Candidates' own declarations regarding whether they meet the application requirements will be taken into account when applying for the quotas. Applications of candidates who are found to have made incomplete or incorrect statements will not be evaluated. Candidates not meeting the application requirements, and candidates making applications and submitting preferences with misstatements will not be granted any rights even if they are placed in a program.

3.2. During the application, information must be entered into the system without errors, documents must be uploaded legibly and completely, and no changes can be made to the information and preferences. (Each applicant may only apply once. There can be no changes after the preferences are made.)

3.3. During final registration, the authentic and approved copy of the documents must be provided. The applicants who are not able to provide said documents are academically dismissed.

3.4. During the application, placement and registration process; transactions of candidates are canceled and their records are deleted at each determined stage in case of falsified, false, incomplete and incorrect document or information entry / declaration even if their final enrollment has been made. Additional / tuition fees they have paid are not refunded. (BUÜ reserves the right to take legal and administrative action in this case.)

3.5. Applications will be made online on the ULUYÖS website and any application submitted in person or via e-mail will not be accepted.

3.6. The conditions of Higher Education Council accepting students from abroad,

A- General Conditions 2.c) item; “The continuation of the practice of applying for foreign student admission quotas within the framework of the criteria determined by the universities in accordance with Article 45/f of the Higher Education Law No. 2547, amended by Law No. 6287, and the Principles Regarding the Admission of Students from Abroad, determined by the Higher Education Council, it is possible to apply for

the quota for student admission from abroad; candidates who have obtained a permit and who certify that they have the Certificate on the Exercise of the Granted Rights (blue card), given to their underage children registered on the certificate of renunciation of Turkish citizenship, continued their secondary education abroad before 01/02/2013 and spent the last three years of their secondary education (high school) in a foreign country excluding the TRNC, Türkiye nationals who have completed their high school education or who have completed their high school education in high schools abroad (except T.R.N.C. high schools), Türkiye nationals, and one of their nationalities is Turkish, and also;

i) The continuation of determining student quota for the departments of **Teaching, Law, Medicine and Dentistry**, which accept foreign students and are recommended by the Higher Education Board,

ii) However, according to the procedure and principles, the quota for these candidates in the mentioned fields should not exceed 10%. Candidates possessing the specified qualifications should take this into account when making their preferences.

3.7. The preference applications are made based on the examination types and scores accepted by the Bursa Uludağ University Senate. (Accepted examination types and scores are announced on the ULUYÖS web page.) In case the conditions for conducting the aforementioned examinations and the distribution of scores are deemed insufficient, the University reserves the right to reject/apply coefficient to the scores.

4- . PREFERENCE APPLICATIONS AND EVALUATION OF APPLICATIONS

4.1. Preference applications are made via the ULUYÖS Preference Application System based on the examination type scores accepted by the BUÜ Senate. [Click Here](#) to access the list of examination types and scores accepted by the Bursa Uludağ University Senate. (ANNEX-1)

4.2. Preference applications will be accepted online via the Bursa Uludağ University ULUYÖS web page (<https://www.uludag.edu.tr/en/uluyos>) between **May 25th and June 15th, 2026**. Students will be provided with the opportunity to make 5 (five) preferences, and placement procedures will be conducted starting from the first preference.

4.3. At all stages of placement, priority may be given to foreign students coming from countries whose special circumstances are evaluated.

4.4. Priority may be given to foreign students coming from different countries for the sake of country diversity.

4.5. The equivalence and the suitability of the condition of the exam, type and scores to be used in the admission of international students are evaluated by YDOKK. Candidates' exam scores or secondary school (high school) grade point averages are converted to a 100-point system, with 100 (one hundred) points considered the full mark.

4.6. According to the principles stated in the Higher Education Board's Regulations on Admission of Students from Abroad; candidates who, in accordance with the Turkish Citizenship Law, lose their Turkish citizenship by obtaining permission to renounce Turkish citizenship from the Ministry of Interior, candidates who prove that they hold a blue card given to those who have lost Turkish citizenship upon their request, and candidates who have received their high school education abroad (excluding the Turkish Republic of Northern Cyprus) and are dual citizens with one of the nationalities being Turkish, are eligible for registration in the Dentistry, Law, Teaching, and Medicine programs without exceeding 10% of the quota for these programs.

In case of identical placement scores, the placement is made giving priority to the higher high school graduation score and the youngest candidate. Evaluation and placement in quotas are carried out in the following way: based on the highest score, order of preference, and ensuring that candidates from the same country accepted to a department/program for placement do not exceed 20% of the total quota.

4.7. The second placement is conducted among candidates who have not been placed in any department/program from the existing applications; no new preference applications are accepted from candidates.

4.8. If a decision is made to conduct a third placement for the unfilled or vacant quotas, candidates will be notified separately via the ULUYÖS web page, and new applications will be accepted.

4.9. Placements to the departments / programs that are admitted by special talent exams are carried out by the commissions established by the related units.

4.10. During the student selection process, candidates who have earned the right to definitive enrollment will learn about the placement results by logging into the placement result inquiry screen on the Bursa Uludağ University ULUYÖS web page. Candidates may obtain printouts of their acceptance letters from our university's ULUYÖS web page. (Acceptance letters are not sent to candidates via email.)

5- REGISTRATION PROCEDURES

Registration will be carried out in two stages, with online pre-registration followed by definitive registration upon the personal delivery of the required documents. Online pre-registration applications will be made through the ULUYÖS website. Candidates who fail to upload or cannot upload the required documents for online pre-registration during the registration dates, or those who upload incomplete documents, will not be pre-registered. These candidates will be considered to have forfeited their registration rights.

Candidates who have completed their online pre-registration are required to submit the originals of the documents requested for definitive registration, along with the documents they uploaded to the system, to the student affairs of the units they are entitled to register by the announced date, either in person or through a power of attorney given to a lawyer. (If the candidate is under the age of 18, document submission may be made by their parent/legal guardian.)

Candidates who fail to upload the original documents required for pre-registration to the system by the date specified in the 'Placement Results and Registration Procedures Announcement' to be made on the ULUYÖS website will be considered to have forfeited their registration rights. The documents required for registration are listed in Annex-2 of the Guide.

Applicants' own statements regarding whether they meet the application conditions will be taken into account. Applicants who do not meet the application requirements or who make incorrect statements during the application and preference process, even if they have been placed/enrolled, will not be entitled to any rights as a result of this situation.

Individuals who do not have a legal right of residence in Türkiye cannot be enrolled in university. The status of whether candidates have a legal right of residence in Türkiye (visa/residence permit) is evaluated within the scope of legislation determined by relevant Ministries and the Presidency of Migration Management. **If it is determined that candidates do not have a legal right of residence in Türkiye, their registrations will be cancelled, and no refunds will be provided to these candidates.**

The responsibility for preparing all required documents for registration and visa/residence permit procedures lies solely with the candidate. **The University is not obliged to provide any assistance regarding these processes.** Candidates are required to complete the procedures for obtaining a residence permit (visa/residence permit) within the time frames determined by the competent authorities. It is the responsibility of candidates to monitor the residence permit processes. Payments made by candidates for registration will not be refunded if they fail to submit the necessary documents within the specified timeframes, resulting from the inability to obtain a residence permit.

After registration, the relationship between the university and students who are found to not meet the application conditions, who have applied with misleading information or documents, or who have errors in their information and documents will be terminated. In this case, contribution fees and tuition fees will not be refunded for students who have made online pre-registration payments but have not enrolled, or who have enrolled and voluntarily deleted their registration.

The contribution and tuition fees to be collected from foreign students are determined by the university board of management, provided that they remain within the minimum and maximum limits in accordance with the relevant legislation provisions of the "Decision on the Determination of the Current Service Costs and Tuition Fees" published annually in the Official Gazette of the Republic of Türkiye.

The amount of tuition fees/contribution fees that candidates admitted to the international student admission quotas for the 2026-2027 Academic Year must pay during online pre-registration for the 1st semester (Fall Semester) is as follows:

If the Decision Regarding the Determination of Contribution Fees and Tuition Fees to be Taken as Student Contributions for Current Service Costs in Higher Education Institutions for the 2026-2027 Academic Year is published during or after the online pre-registration dates, the contribution fees/tuition fees for the Fall Semester specified in the table announced according to the Decision published in the Official Gazette for the previous year will be charged.

For the 1st semester (Fall Semester) contribution fees/tuition fees for the 2026-2027 academic year, any positive or negative difference in the contribution fees/tuition fees determined by the Board of Directors of our University among the contribution fees/tuition fees for the 2026-2027 academic year, which will be in effect upon publication in the Official Gazette according to the Presidential Decision "Decision on Determining the Contribution Fees and Tuition Fees to be Taken as Student Contributions for Current Service Costs in Higher Education Institutions for the 2026-2027 Academic Year", will be collected along with the following Spring semester contribution fees/tuition fees. (Any positive or negative differences due to changes made by the competent authorities in the Decision to be announced, or due to the contribution fees/tuition fees determined by the Board of Directors, will be collected along with the following Spring semester contribution fees/tuition fees.) The amounts of Contribution Fees/Tuition Fees are announced to candidates on the ULUYÖS website.

Candidates must also declare, by signing the Financial Status Declaration Form during online pre-registration, that they have sufficient financial means to continue their higher education in our country and to support themselves financially.

According to the legislation and decisions that will come into effect after the publication date of the Guide, Bursa Uludağ University has the authority to make changes. All applicants and enrolled candidates are deemed to have accepted the obligation to comply with these regulations.

6- FINAL PROVISIONS

Communication between the Bursa Uludağ University Overseas or Foreign Student Selection, Placement, and Admission Commission (YDOKK) and candidates is conducted electronically in Turkish and English languages via the email address yos@uludag.edu.tr. The email address provided by the candidates during the preference application process must be current and accurate. Each candidate should use only one email address. Correspondence/transactions should not be conducted on behalf of other candidates using this email. After the candidate number is assigned, it is mandatory to specify the "Candidate Number" in all correspondence with Bursa Uludağ University. Petitions/applications without a Candidate Number will not be processed. Correspondence and notifications with candidates are considered official notifications. Candidates are required to regularly check their email addresses throughout the entire calendar process. The University is not responsible for any disruptions during communication.

Bursa Uludağ University is free to fill or not fill the announced quotas. Meeting the required conditions for application does not guarantee acceptance.

For residence permit procedures, candidates are required to make an online residence permit application through the Presidency of Migration Management website and submit the required documents in person or through a power of attorney given to a lawyer to the **Directorate of Student Affairs International Student Unit**. Residence Permit Documents and Information are available on the ULUYÖS website.

International students who have entered or will enter our country are required to obtain the General Health Insurance (GHI) from the Social Security Institution (SGK) during university registration. Students covered by GHI should pay the necessary premiums to the SGK Presidency and add the GHI Certificate to the school registration and residence application file. Detailed information regarding the implementation will be announced on the ULUYÖS website.

According to the decision taken by the Executive Board of the Council of Higher Education (YÖK) on 13.03.2024 with the decision number 15951:

a) In accordance with the decision that international students can change the university they are registered in only once within the same academic year, candidates who will apply for preference or have already applied should consider this and make their preference application accordingly. The university reserves the right to evaluate the preference applications of candidates in this situation and delete their registrations. If the registrations of candidates in this situation are deleted, the contribution fee/tuition fee paid will not be refunded.

b) **International students who enrollment is not renewed for two consecutive years in four year programs or one year in two years programs and who fail to pay the tuition fees may have their registration terminated by the decision of the relevant department's board of directors.** If the registrations of candidates in this situation are deleted, the contribution fee/tuition fee paid will not be refunded.

The duration of the Preparatory Class (Turkish or Foreign Language) is 2 years, and the registrations of candidates who fail to complete it within this period will be deleted. If the registrations of candidates in this situation are deleted, the contribution fee/tuition fee paid will not be refunded.

Bursa Uludağ University has the authority to make changes to all announced dates and conditions related to preference applications, registration procedures, contribution fee/tuition fee amounts, etc. All notifications regarding the procedures to be carried out, newly taken decisions, information about necessary changes, and principles regarding implementation will be announced to the candidates through our university's official communication channel, the ULUYÖS website. Any information or sharing made outside of this official channel should not be relied upon. All changes and announcements made on the ULUYÖS website are considered official notifications to the candidates.

The university's official email address is yos@uludag.edu.tr Candidates are required to monitor their email addresses and announcements made on the ULUYÖS website. Additionally, candidates will not be notified via postal mail. Candidates are responsible for any loss of rights that may occur due to failure to follow announcements.

Applying for foreign student admission quotas implies the acceptance of all the provisions outlined in this **Guide and Directive** on Bursa Uludağ University's Admission of International Students available on the ULUYÖS website.

The information, explanations, and rules stated in this Guide may be subject to change in accordance with decisions made by the Bursa Uludağ University Senate/Board of Directors and/or the Council of Higher Education (YÖK) and other official institutions after the publication date of this Guide. In such cases, the procedures to be followed will be determined by the YDOKK. In cases not specified in the Directive and Guide, decisions will be made by the YDOKK based on the directives given by the ULUYÖS Coordinator.

ANNEX-2 REQUIRED DOCUMENTS FROM CANDIDATES ENTITLED TO DEFINITIVE REGISTRATION FOR FOREIGN STUDENT ADMISSION QUOTAS

1) A photocopy of the high school diploma or temporary graduation certificate

- (The original will be seen and copied. If in a language other than Turkish or English, a photocopy of the Turkish translation certified by a notary public or Turkish foreign representative offices is required.)

2) An official note card certified by the high school administration showing the courses taken, grades, and overall grade point average of the candidate in high school (The original will be seen and copied.) (Transcript)

ANNEX-5 BUÜ CLARIFICATION TEXT REGARDING PROTECTION AND PROCESSING OF PERSONAL DATA

Bursa Uludağ Üniversitesi (BUÜ) takes the highest level of security measures possible to ensure the lawful collection, storage, and sharing of your personal data and to protect your privacy. Our aim is to transparently inform you about the ways and legal reasons for the collection of your personal data, processing purposes, and your rights, in accordance with Article 10 of the Law on Protection of Personal Data No. 6698 (Law No. 6698).

a) Data Supervisor

In accordance with the provisions of the Law on the Protection of Personal Data No.6698 ("KVKK"), as the Bursa Uludağ University (BUÜ) ULUYÖS Coordinator, entitled as Data Supervisor, we inform you about our mutual rights and obligations within the scope of the mentioned legal regulation. Your personal information can be recorded, stored, updated, disclosed to third parties when permitted by the legislation, transferred, classified and processed in the ways listed in the KVKK.

b) Purposes of Processing Personal Data

Data about International Students' entrance-exit dates, residence, exam application preferences, transactions student relationship, the scope of the fulfillment of the performance and discipleship process, identity / passport, address, T.C./Y.U. numbers, other necessary information including the Identification Number and personal data; all records and documents that processed in electronic (internet / mobile etc.) or paper environment will be stored by authorized institutions and other authorities within the scope of the legislation. The purpose of the legislation is to comply with the information storage, reporting and information obligations stipulated by the authorized institutions and other authorities, to increase the quality of service with marketing and statistical activities, to provide requested / other products / services. Special quality personal data are processed within the contractual relationship due to communication, information and similar processes.

c) The Parties and Purposes for Which Processed Personal Data Can be Transferred

Persons or organizations to which personal data can be transferred for the purposes stated above are persons, public institutions and organizations and private public institutions and organizations permitted by the provisions of legal legislation. - In case of damage due to illegal processing of personal data, you have the right to request compensation for the damage.
